- c. Creating Collective Care Conference took place in February 2024. It was over 3 days had a variety of sessions, approximately 150 attendees during the conference. It was a partnership with CSNPEI, UWPEI, ACSWPEI. It was a great success and will hopefully organize another conference soon. Received great feedback from attendees in the conference.
- d. Advocacy we advocate for the betterment of the sector. We had the opportunity to attend Imagine Canada's not for profit hill days to lobby government for changes. Met with 40



MPs, Senators and their staff. Making federal funding more equitable, creation of a home in government for the nonprofit sector. Advocating for a sector wide labour and workforce strategy, better collection of data about the sector for effective decision-making as well as raising awareness about the impact of the Alternative Minimum tax on donations.

Increasing core funding instead of project funding. Creating a home in government, developing a volunteer recovery strategy and increasing awareness of the sector's contributions.

Board Candidates Biography

Bukola Afolabi
